General Agreement Waiver and Release (initial) _____

CITIZEN'S CONSTABLE ACADEMY & RIDE-ALONG PROGRAM- The undersigned voluntarily wishes to participate in the citizen's academy and ride-along program, which is a hazardous activity with the potential for death, serious injury and property loss. The risks include but are not limited to; those caused by terrain, facilities, temperature, weather, condition of equipment, vehicular traffic, and negligent and non-negligent actions of other people including, but not limited to participants, volunteers, officers and citizens. I hereby assume all the risks of participating in the citizens' academy and ride-along program. I certify that I am physically able to participate in the citizen's academy and ride-along program and have not been advised otherwise by a qualified medical person. GENERAL AGREEMENT - WAIVER AND RELEASE (Adults over 18) In consideration for being permitted by the Nueces County Pct. 5 Constable Office to participate in the above activity, I hereby WAIVE RELEASE, and DISCHARGE any and all claims for damages for personal injury, death, or property damage, which I may have or which may hereafter accrue, as a result of my participation in said activity. This release is intended to discharge, in advance although the liability may arise out of negligence or carelessness on the part of said County, Constable Oscar Mendoza Jr., or their officers, employees or agents, connected in any way with my participation in said activity. I understand that the above activity may be of a hazardous nature and/or include physical and/or strenuous exercise or activity; that serious accidents occasionally occur during the above activity, and that participants in the above activity occasionally sustain mortal or personal injuries and/or property damages as consequence thereof. Knowing the risks involved, nevertheless, I have voluntarily applied to participate IN SAID ACTIVITY, AND I hereby assume all risks of injury or death and RELEASE and HOLD HARMLESS the County of Nueces, Constable Osscarr Mendoza Jr. and their officers, employees and agents who through negligence, carelessness, or any other act or omission might be liable to me. I further understand and agree that this waiver, release and assumption of risks is to be binding on my heirs and assigns. And upon anyone claiming by, through or under me. I FURTHER AGREE TO INDEMNIFY and to HOLD the County of Nueces, Constable Oscar Mendoza jr., and their officers, employees and agents FREE and HARMLESS from any loss, liability, damage, cost or expense which they may incur because of any injury and/or property damage, or claim made against or by me.
